- All students will have an awareness and understanding of diverse belief systems and cultures.
- All students will feel successful throughout their lives.
- All students will have confidence in themselves.
- All students will meet or exceed district academic standards.

Farmington Area Public Schools Guidelines for Disciplinary Action

Every student and employee of Farmington Area Public Schools is entitled to learn and work in a safe school environment. To ensure this, the district and each school have established clear student discipline policies, consequences appropriate with the behavior, and a practice to do so consistently.

Students are expected to behave in accordance with federal, state, and local laws and rules; district, athletic and activity policies and school regulations; and to do so in a manner that respects the rights and safety of others. Staff will take corrective action when student behavior does not fall within the guidelines. Consequences are considered cumulative for the student's academic career.

The following are district-wide discipline guidelines. These guidelines and the potential consequences apply at any time a student is present on school district property or participating in a school-sponsored activity. Listed are the violations and the <u>recommended</u> consequences. The infractions and consequences may be modified or disregarded if circumstances require mitigation or exception (e.g. disabled student whose misbehavior is related to his or her disability). These guidelines are based upon Farmington Area Public Schools Board of Education Policies.

Abuse, Verbal

The use of language that is obscene, threatening, intimidating, or that degrades other people is prohibited. Verbal abuse that is also sexual, religious, or racial harassment shall be addressed under the guidelines for harassment. Whoever threatens, directly or indirectly, to commit any crime of violence with purpose to terrorize another; or to cause evacuation of a building, place of assembly, vehicle, or facility of public transportation; or otherwise to cause serious public inconvenience; or in a reckless disregard of the risk of causing such terror or inconvenience; may be sentenced to imprisonment for not more than five years or to payment of a fine of not more than \$10,000 or both.

Alcohol or Chemicals, Possession or Use

Minnesota or federal law prohibits possession or use of any alcohol, narcotic, controlled substance, or drug paraphernalia. Any student in possession of, using, or under the influence of alcohol, narcotics, controlled substances (this includes over the counter and misuse of prescription drugs), or drug paraphernalia at a school property or at a school event will be reported to the police. Further recommendation such as possible chemical assessment may also be required. A chemical assessment may be recommended on a second school offense prior to readmission to school. Consequences are considered cumulative for the student's academic career.

Alcohol or Chemicals, Possession with Intent to Distribute or Sell

Selling, distributing, delivery, exchanging or intending to sell, deliver, exchange or distribute any alcoholic, narcotic or controlled substance (this includes over the counter drugs, misuse of prescription drugs, and intent to sell drugs or drug-look-alikes), at a school location or at a school event is prohibited.

Arson
The intentional setting of or attempt to set a fire that results in, or could have potentially resulted in, the destruction or damage to school property or other property or that endangers or potentially endangers others by means of fire is prohibited.

Committing an assault upon another person with a weapon, or an assault, which inflicts great bodily harm upon another person, is prohibited.

Assault, Physical

Acting with intent to cause fear in another person of immediate bodily harm or death, or intentionally inflicting or attempting to inflict bodily harm upon another person is prohibited.

Intentionally making, publishing, or conveying in any manner a bomb threat or any other type of terroristic threat pertaining to a school location and property of the school or event is prohibited.

Bullying and/or Intimidating Behavior

Bullying and/or intimidating behavior of any type is prohibited. The misuse of technology including, but not limited to, teasing, intimidating, defaming, threatening, or terrorizing another student, teacher, administrator, volunteer, contractor, or other employee of the school district by sending or posting e-mail messages, instant messages, text messages, digital pictures or images, or Web site postings, including blogs, also may constitute an act of bullying regardless of whether such acts are committed on or off school district property and/or with or without the use of school district resources. State and County guidelines will be adhered to.

Dress and Grooming

Dress and grooming on a school location in the following manner is prohibited.

- Wearing clothing that includes words or pictures which are obscene, vulgar, abusive, discriminatory, or which promote or advertise alcohol, chemicals, tobacco, violence or any other product that is illegal for use by minors.
- Wearing clothing and other items or grooming in a manner that represents and/or promotes threat/hate groups including gangs or supremacist groups.
- Wearing clothing or grooming in a manner that is sexually explicit or which conveys sexual innuendo or that may reasonably be construed as sexual.
- Wearing of clothing or grooming that is potentially disruptive to the education process or that poses a threat to the health and safety of others
- Wearing of head gear (this includes caps, hoods, and bandanas) is not permitted.
- Outer jackets or coats should not be worn during the school day.

Fire Extinguisher, Unauthorized Use

Fireworks or Possession of Ammunition

Possession, distribution, or use of any type of fireworks (sparklers, firecrackers, smoke bombs) or ammunition is prohibited. Police referral will be made when state law has been violated. (Note, use of any firework or ammunition that creates a serious disturbance or safety hazard may be considered a violation of the "Explosive and Incendiary Devices/Detonation of Ammunition" provision listed earlier in this booklet.)

Harassment

Racial, gender, religious, age, disability, sexual orientation, marital status, and public assistance harassment and violence as defined in the district policy is prohibited. Reprisal or retaliation for a complaint of harassment is prohibited. A referral to police will be made on any action that can be defined as a hate crime. "Harassment" includes all forms of racial, religious, and sexual harassment. Sexual harassment consists of unwelcome sexual advances; request for sexual favors; sexually motivated physical conduct or other verbal or physical conduct; communication of a sexual nature, when submission to that conduct is made a term, or condition, for obtaining an education, or submission to or rejection of the conduct is used as a factor in decisions affecting the student's education, or the conduct has the purpose of effect of unreasonably interfering with the student's educational environment. Sexual harassment can involve but is not limited to unwelcome verbal harassment, unwelcome pressure for sexual activity, unwelcome sexually motivated or inappropriate patting, pinching or physical contact. School Handbooks are even more descriptive regarding this offense.

Hazing

The district maintains a learning environment that nourishes respect for the individual. Hazing activities of any type are prohibited at all times. Hazing, by its very nature, often occurs off school grounds, after school hours, on non-school days and during summer months. Students are advised that hazing is prohibited whenever and wherever it occurs. For more information, refer to the District Hazing Policy (Policy ACC).

Multiple/Chronic Violations

A student, who accumulates excessive referrals or several referrals for serious behavior, may be disciplined in light of the student's overall record. The student and parent will have a warning conference with a principal, and other appropriate staff members, to make them aware that the student is accumulating too many referrals. Any student who has been suspended for violations of the guidelines may be recommended for expulsion upon his or her return if he or she commits additional offenses of the same nature.

Nuisance Objects

Misuse or distribution of any object that causes distractions, such as pagers, radios, cell phones, squirt guns, video games, handheld computers, snaps, stink bombs, laser pointers etc. is prohibited.

Technology and Telecommunication Misuse

Misuse of computer equipment or network; deletion or violation of password-protected information, computer programs, data, passwords, or system files; inappropriate accessing of files, directories, Internet sites; deliberate contamination of system; unethical use of information or violation of copyright laws, is prohibited. It is expected that students will abide by the Acceptable Use Procedures. Parents are expected to read and discuss this guideline with their student. NOTE: Severity of network intrusion could result in police and/or federal investigation.

Theft, Receiving or Possessing Stolen Property

The unauthorized taking, using, transferring, hiding, or possessing of the property of another person without the consent of the owner, or the receiving of such property, is prohibited. Restitution, when appropriate, will be required.

Threatening Physical Harm Toward Students, Staff Members or Other Persons

Making comments that could be interpreted as death threats or insinuating the infliction of serious bodily harm upon students, staff members, or other persons is prohibited.

Tobacco Use or Possession

Possession or use of tobacco in any form on school property, in personal vehicles, in district buses or vehicles, or at district events, is prohibited. Consequences to students will be sequential and inclusive during their career within the District they attend.

Trespassing

Presence at any school location without permission of school personnel is prohibited. Students are not to go into other district buildings unless they have permission from the building administrator. Any student on suspension who goes to any school district location without permission is subject to being charged with trespassing and an increase in suspension time. Admitting others through a locked or secured entrance without the permission of school personnel is prohibited.

Truancv

Farmington Area Schools have developed attendance policies consistent with current state, and county guidelines.

Compulsory attendance policies for students under the age of 16 years will be applied in cases of chronic absences or tardiness. Absences or tardiness which are not lawful include oversleeping, staying home to baby-sit, and missing the bus. A warning letter will be sent to the parent/guardian. A student under the age of 16 years with more than 7 unexcused absences may be referred to Dakota County Juvenile Court. For more information, refer to District Policy JE

Unique Situations

Discipline situations that arise which are not covered by these guidelines will be handled on a case-by-case basis. Behaviors that are willful and disruptive or potentially harmful, including "pranks" are included. Unique or special situations at a particular school may call for an adjustment in the discipline policies to meet the school or District's needs.

Vandalism, Minor Acts (Less than \$500)

Littering, defacing, cutting, or damaging property that belongs to the school district, other students, staff members, or other individuals is prohibited. Placement of graffiti on any school property is defined as "unauthorized markings of paint, dye, or other similar substance that have been placed on real or personal property, or the authorized etching or scratching of the surfaces of such property, any of which markings, scratches, or etchings are visible from premises open to the public."

Vandalism, Major Acts (More than \$500)

Littering, defacing, cutting, or damaging property that belongs to the school district, other students, staff members, or other individuals where damages are over \$500 are considered major acts of vandalism. Placement of graffiti on any school property is defined as "unauthorized markings of paint, dye, or other similar substance that have been placed on real or personal property, or the unauthorized etching or scratching of the surfaces of such property, any of which markings, scratches, or etchings are visible from premises open to the public."

Vehicle, Unauthorized Parking

Not having a parking permit or parking a motorized or non-motorized vehicle in unauthorized areas on school property is prohibited. Failure to adhere to parking regulations may result in towing or mechanical immobilization without warning.

Weapons (exclusive of firearms)

The possession, real or implied, and or use of items (for example but not limited to, knives, objects designed like a weapon, chains, arrows, air guns, bb guns, blades, clubs, metal knuckles, and objects that have been modified to serve as a weapon) which are considered dangerous, illegal, or which could possibly cause harm, destruction or disruption is strictly prohibited on school property or at school activities. This includes weapons and items designed for other purposes but can be used to inflict bodily harm or intimidate such as files, pencils, and scissors are also prohibited.

Additional Discipline Information

<u>Police Referral</u> • Administrators will involve the police or other law enforcement authorities as necessary. If a student violates a district policy that also violates a law, the student will be referred to the police.

Special Education or Disabled Students • Consequences for Special Education or disabled students will be adjusted, as required by federal and state laws and regulations, and the student's individual education plan (IEP) or accommodation, when necessary. Special Education students and their parents may request modification of those policies and accommodations where appropriate.

<u>Unique Situations</u> • Because it is not possible to list every violation that occurs, those not specified will be responded to as necessary by staff on a case-by-case basis. Unique or special circumstances at a particular school may call for an adjustment in the discipline policies to meet the school's needs.

<u>Modification of Consequences</u> • Consequences for a specific violation can be adjusted on an individual basis at the discretion of building administration.

<u>Parental Questions About Discipline</u> • Parents may contact building administration to discuss an infraction and consequence assigned if they have questions regarding the situation.

<u>Corporal Punishment</u> • Independent School District 192 strictly prohibits corporal punishment. Corporal punishment involves the hitting or spanking of a person with or without an object or any unreasonable force that causes bodily harm or substantial emotional harm.

Physical Restraint • Physical restraint may be utilized by administrators, teachers, and other staff only where it is necessary to use reasonable force to restrain a student from injuring himself or herself, others, or property.

<u>School District Locker Policy</u> • It is the policy of Independent School District 192 and the State of Minnesota that school lockers, desks and other areas assigned to a student are the property of the school. At no time does the school relinquish its exclusive control of lockers provided for the convenience of students. <u>School authorities may conduct inspection of lockers for any reason at any time, without notice, without student consent, and without search warrants.</u>

The personal possessions of a student within a locker may be searched only when school authorities have reasonable suspicion that the search will uncover evidence of a violation of law or school rules.

As soon as practicable after the search of a student's personal possessions, the school must provide notice of the search to the student whose locker was searched unless such disclosure would impede an ongoing investigation by police or school officials.

<u>Discipline Procedures</u> • All disciplinary actions shall be processed pursuant to District 192's discipline policy and the requirements of the Minnesota Pupil Fair Dismissal Act.

- Any student who violates a school policy or rule may be subjected to the consequences established in the student handbook.
- Any student who violates a school policy that has a potential consequence of dismissal from school for more than one school day shall have an informal conference with a school administrator. An informal conference is not required where the student is creating an immediate and substantial danger to himself or herself or to surrounding persons or property.

Any student who is being dismissed from school for more than one day will be provided written notice containing a statement of the facts giving rise to the dismissal (including pertinent statements of staff members and the student), the grounds for dismissal, a copy of the Pupil Fair Dismissal Act, and a plan established for the student's readmission. The parents or guardian of the dismissed student shall be provided written notice of the dismissal by certified mail within 48 hours of the informal conference. The parent's notice will include all the elements contained in the student's notice.

- Any suspension that exceeds ten days in length will be accompanied by an explanation to the superintendent listing the
 reasons why the suspension exceeded ten days in length.
- All students who violate a school policy or rule that has a potential consequence of exclusion or expulsion will be given
 the opportunity to have a hearing over the issue of exclusion or expulsion in accord with Minnesota law. (See
 Minnesota Statue #127.27 to 127.38.)

Definitions

"Exclusion" means an action taken by a School Board to prevent enrollment or reenrollment of a pupil for a period, which shall not extend beyond the school year.

"Expulsion" means an action taken by a School Board to prohibit an enrolled pupil from further attendance for a period that shall not extend beyond an amount of time equal to one school year from the date student is expelled.

"Removal" means any action taken by a teacher, principal, or other school district employee, to prohibit a pupil from attending class for a period not to exceed five class or activity periods. A student may be removed from class for violating the district's discipline policy, or for willful conduct that disrupts the rights of others to an education, or which endangers other individuals or the property of the school.

"School location or property" includes a school building, school grounds, school activities or trips, bus stops, school buses or school vehicles, school-contracted vehicles, the areas of entrance or departure from school premises or events, and all school related functions.

"School personnel" means any person employed or under the direction/assignment of school personnel and who is acting within the scope of their assignment.

"Suspension" means an action taken by the school administration, under the district's discipline policy, which prohibits a pupil from attending school. This definition does not apply to dismissal from school for one school day or less. In no event shall a single suspension exceed 15 school days, provided that an alternative program shall be implemented when that suspension exceeds ten days.

Possible Disciplinary Consequences

District staff can use the following consequences or actions when discipline infractions occur. These could include:

- Student conference.
- Parent/guardian conference.
- Fine A financial penalty assessed of a student by the school.
- Restitution Compensation or compensatory service required of a student who has damaged, taken or destroyed school or personal property.
- Offensive behavior class Assignment to an out-of-school class involving cases of sexual harassment, racially
 offensive behavior or speech and actual or threatened violence.
- **Tobacco education class -** Assignment to an educational class when the tobacco policy is violated.
- Smoking cessation class Assignment to a smoking cessation class when the tobacco policy is violated.
- Truancy referrals Referral to Dakota County authorities when unexcused absences exceed the legal limits.
- Removal from class Removal from a particular class for up to five class periods due to inappropriate behavior.
- In-school suspension Removal from classes to an in-school suspension room under the direction of staff.
- Out-of-school suspension Action taken by the school administration, under the district's discipline policy, which
 prohibits a pupil from attending school. This definition does not apply to dismissal from school for one school day
 or less. In no event shall a single suspension exceed 15 school days provided that an alternative program shall be
 implemented to the extent that suspension exceeds ten days. Students may not be on school property during the
 suspension or they are subject to trespassing.
- <u>Police referral</u> Contact by the school administration with the local police department to inform them about illegal behavior engaged in by a student.
- <u>Exclusion</u> Action taken by the School Board to prevent enrollment or re-enrollment of a student for a period which shall not extend beyond the school year.
- <u>Expulsion</u> Action taken by the School Board to prohibit a student from attending school for a period that shall not extend beyond an amount of time equal to one school year from the date a pupil is expelled.
- Restriction or loss of school privileges.
- Suspension from extra curricular activities.
- Other disciplinary action deemed appropriate by Independent School District 192
